RESERVATION DEPOSIT

Reservations must be accompanied by a 25% deposit of the total anticipated cost of the trip

CANCELLATION POLICY

Our cancellation policy applies to all reservations. We regret that we cannot make exceptions to the Cancellation Policy for any reason, including personal emergencies. Only the management has the authority to grant or promise refunds.

1. If written cancellation is received 30 days prior to departure date for All Expense Trips, refunds will be issued, minus a \$50 cancellation fee per person.
2. If written cancellation is received 15 days prior to departure date for All Expense Trips, refunds will be issued, minus a \$100 cancellation fee per person.
3. On all other trips there will be a \$50 cancellation fee per person if written cancellation is received at least 15 days prior to departure date.
4. No refunds will be made if written cancellation is not received by cancellation deadline.
5. No refunds will be made if the party or individual terminated their trip early.
6. If for any unknown circumstances Reid Horse & Cattle Co., Inc. has to cancel the trip, all fees paid will be refunded.

RELEASE AND WAIVER OF LIABILITY

I certify that I and/or my minor children are in good health and have no prior medical conditions that could be aggravated by participating in horseback riding activities. I am aware that riders may fall off and that horses can and do throw riders, kick and bite. I am aware that riding horses and being near them are hazardous activities and I am voluntarily participating in these activities with knowledge of the danger involved and hereby agree to accept any and all risks of injury. I have carefully read this agreement and fully understand its contents. I am aware that this is a release of all liability including asserted negligence and is a contract between myself and Reid Horse & Cattle Co., Inc and its employees and owners and sign it of my own free will.
